For purposes of this Subpoena,

"documents" "records" and "files" are meant to refer as broadly as possible to complete and un-redacted forms of stored information including electronic mail, text messages sent via portable communication devices, paper hardcopy originals, photocopies and any type of images or other storage media whether found on tape, disc, microfilm, microfiche or any other electronic, magnetic, digital, optical or other machine-readable format.

"possession or control" is meant to refer as broadly as possible to any records and files accessible to you or your agents or attorneys.

"Phoenix New Times" or "Phoenix New Times newspaper" are meant to refer to the free, weekly newspaper that is published every Thursday, or thereabouts, in the greater Phoenix area.

4. All documents related to an article believed to be written by Stephen Lemons entitled "Joe Strikes Back," published by the Phoenix New Times newspaper on or about December 21, 2006.
