SCOTT EVANS AND ROY VANDEWATER, on or between the 23rd day of November, 2005 and the 27th day of November, 2005, with intent to commit a theft or a felony therein, entered or remained unlawfully in or on a non-residential structure of DESERT MOUNTAIN HIGH SCHOOL, located at 12575 EAST VILLA LINDA IN SCOTTSDALE, in violation of A.R.S. §§ 13-1501, 13-1506, 13-301, 13-302, 13-303, 13-304, 13-701, 13-702, 13-702.01, and 13-801.

COUNT 2:

SCOTT EVANS AND ROY VANDEWATER, on or between the 22nd day of December, 2006 and the 24th day of December, 2006, with intent to commit a theft or a felony therein, entered or remained unlawfully in or on a non-residential structure of DESERT MOUNTAIN HIGH SCHOOL, located at 12575 EAST VILLA LINDA IN SCOTTSDALE, in violation of A.R.S. §§ 13-1501, 13-1506, 13-301, 13-302, 13-303, 13-304, 13-701, 13-702, 13-702.01, and 13-801.

COUNT 3:

SCOTT EVANS AND ROY VANDEWATER, on or between the 27th day of March, 2007 and the 2nd day of April, 2007, with intent to commit a theft or a felony therein, entered or remained unlawfully in or on a non-residential structure of DESERT MOUNTAIN HIGH SCHOOL, located at 12575 EAST VILLA LINDA IN SCOTTSDALE, in violation of A.R.S. §§ 13-1501, 13-1506, 13-301, 13-302, 13-303, 13-304, 13-701, 13-702, 13-702.01, and 13-801.

on or about the 7th day of April, 2007, with intent to commit a theft or a felony therein,

entered or remained unlawfully in or on a non-residential structure of DESERT M HIGH SCHOOL, located at 12575 EAST VILLA LINDA IN SCOTTSDALE, in violation of A.R.S. §§ 13-1501, 13-1506, 13-301, 13-302, 13-303, 13-304, 13-701, 13-702, 13-702.01, and 13-801.

COUNT 5:

SCOTT EVANS, THOMAS VITO COLETTO,

on or about the 7th day of April, 2007, intentionally, knowingly, or recklessly, without the express permission of DESERT MOUNTAIN HIGH SCHOOL, the owner, caused damage in the amount of \$1,500 or more but less than \$10,000, by defacing or damaging a building, structure, or place, located at 12575 EAST VILLA LINDA IN SCOTTSDALE, used as a school or educational facility, in violation of A.R.S. §§ 13-1604, 13-1601, 13-301, 13-302, 13-303, 13-304, 13-701, 13-702, 13-702.01, and 13-801.
