

Affidavit of Margaret Purnell

Beginning in late October, 1999, I was a client of Daril Cinquanta and his company, Professional Investigators. I was referred to Mr. Cinquanta by a mutual friend, and Mr. Cinquanta represented and advised me until December, 2007.

I am currently involved in litigation against Mr. Cinquanta and his associates, for what I believe to be fraudulent legal documents proffered by Mr. Cinquanta in an attempt to perfect the theft of my real estate property located in Summit County, Colorado.

I am also a potential witness in the Mark Paschall criminal trial, and I have given a statement to Mr. Paschall's defense attorney David Lane, regarding my knowledge of Mr. Cinquanta providing free accommodations to prosecution witness Sarah Kathy Redmond and potentially other Jefferson County Government officials and associates. It is my lakefront condominium that is the subject of that investigation.

From about June, 2005, until May, 2006, I had been a listener of the radio program, Colorado Exposed, on AM 630 KHOW, hosted by Mike Zinna. Mr. Zinna's show was unique and interesting to me, in that he focused on government corruption. I regularly emailed the show to correspond with Mr. Zinna about corruption issues in general and in Summit County. At some point, Mike Zinna asked me to be a guest on his radio program.

After Mr. Zinna's invitation, I informed Mr. Cinquanta that I had been invited to appear on a radio show in Denver, and asked Mr. Cinquanta if he was willing to accompany me to the studio. At that time, I had no idea that Mr. Zinna and Mr. Cinquanta were acquainted with one another.

Mr. Cinquanta stated that he would be very happy to go with me on the radio, and further stated that as a former police officer, he had plenty of experience "handling the media." Mr. Cinquanta asked which radio show, and I informed him that it was "Colorado Exposed with Mike Zinna."

At that moment, Mr. Cinquanta became very upset, and immediately launched into a diatribe that included many negative references to Mike Zinna. Because of Mr. Cinquanta's statements, I declined Mr. Zinna's invitation to appear on the radio show.

Thereafter, Mr. Cinquanta would regularly make disparaging statements about Mr. Zinna to me. I admitted to Mr. Cinquanta that I was a fan of Mr. Zinna's show and that I thought he was doing good things. This only heightened Mr. Cinquanta's anger regarding Mr. Zinna.

In the summer of 2006, Daril Cinquanta called me to say that one of his friends had put up a website named, www.coloradowackoexposed.com, to show "the real Mike Zinna." After checking the website, I called Daril Cinquanta back and said, "This is horrible, this is awful." Cinquanta replied, "It's the truth - Zinna's a bastard. These are all public records. My friends and I are exposing him, we're going to destroy him."



I asked Mr. Cinquanta why he hated Mike Zinna.

Mr. Cinquanta's reply was, "That mother-fucker has messed with me and with Jim (Congrove) and I'm pushing back. Zinna shouldn't have messed with us".

On another occasion Mr. Cinquanta stated to me, "I'm going to destroy fucking Zinna."

And later, after some negative press had been directed towards Jefferson County Commissioner Congrove, Mr. Cinquanta stated to me, "That fucking Zinna won't let up on Jim, I'll fucking destroy him. He doesn't know who he's fucked with."

The statements made to me by Mr. Cinquanta were particularly disturbing, because Mr. Cinquanta usually did not use profanities around me, except when speaking of Mr. Zinna.

On several occasions Mr. Cinquanta called to advise me to "check-out" a new document his friend had put up on www.coloradowackoexposed.com. Mr. Cinquanta stated that his friend, "Had lots more documents and Zinna will be finished."

Mr. Cinquanta didn't name his friend who was posting the documents to the website. Although Mr. Cinquanta clearly knew a lot about the website events and admitted to being involved, I wasn't sure if it was Mr. Cinquanta who was actually posting the documents. It appeared to me that Mr. Cinquanta lacked the specific computer skills to do the postings.

Mr. Cinquanta later stated to me, "Zinna is suing the website people but it won't go anywhere."

I state under penalty of perjury that the foregoing is true and correct.
